**APPLICATION FOR ORDER TO
SHOW CAUSE**

1 The Plaintiffs in their Complaint hereby request that this Court issue an Order to
2 Show Cause why the relief requested in the Complaint should not be granted. Plaintiffs
3 may proceed by special action where there is no equally “plain, speedy, and adequate
4 remedy” available. A.R.S. § 12-2001, 12-2021, Rules of Procedure for Special Actions
5 (“RPSA”) 1. Rule (4)(c) of the Arizona Rules of Procedure for Special Actions provides
6 that the special action may be instituted with an application for an Order to Show Cause
7 why the requested relief should not be granted. In such instances, the court *shall* set a
8 speedy return date. *Id.* The Verified Complaint makes such a request which the Plaintiffs
9 restate in this Application, Plaintiffs’ reasons for the request are set forth in the Verified
10 Complaint.

11 This is an election-related case and Plaintiffs request that a return hearing be set
12 prior to the start of canvassing on November 9th, 2020.
