MINUTE ENTRY

Before the Court are Plaintiff's Verified Petition for Rule 27 Discovery, and Application for Order to Show Cause and for Order Granting Alternative Service or Service by Publication, which were filed at 4:55 p.m. on Tuesday, November 24, 2020. Due to the urgency of this matter, the Court will hold a hearing on the next judicial day, which is November 30, 2020.

Good cause exists to permit alternative service by email as described below. Service by publication—a remedy normally reserved for defendants who cannot be found, and which almost never provides actual notice—is not justified.

IT IS ORDERED setting a hearing on Plaintiff's Verified Petition for Rule 27 Discovery for **Monday, November 30, 2020 at 10:30 a.m.** The hearing will be held by videoconference via GoToMeeting. The GoToMeeting login information will be emailed to counsel of record. **Only counsel of record and their clients may appear by GoToMeeting, and each person appearing by GoToMeeting shall appear by video.** A separate dial-in number will be provided for those observing the hearing who are not participating in it.

IT IS FURTHER ORDERED that the persons from whom discovery is sought be served by email **no later than 4:00 p.m. on Wednesday, November 25, 2020.**

IT IS FURTHER ORDERED that Respondents be served **no later than 4:00 p.m. on Wednesday, November 25, 2020** by (1) email to the Biden campaign, and (2) email to all counsel of record for the Arizona Democratic Party in CV2020-014553.

IT IS FURTHER ORDERED that the Attorney General, the Secretary of State, the Maricopa County Recorder, and the Maricopa County Attorney be served by email **no later than 4:00 p.m. on Wednesday, November 25, 2020.**

IT IS FURTHER ORDERED that service include a copy of this order. Service of this order provides notice of the hearing and informs the person served that the Court will rule on Plaintiff's Verified Petition for Rule 27 Discovery at the hearing.

NOTE: All court proceedings are recorded digitally and not by a court reporter. Pursuant to Local Rule 2.22, if a party desires a court reporter for any proceeding in which a court reporter is not mandated by Arizona Supreme Court Rule 30, the party must submit a written request to the assigned judicial officer at least ten (10) judicial days in advance of the hearing, and must pay the authorized fee to the Clerk of the Court at least two (2) judicial days before the proceeding. The fee is \$140 for a half-day and \$280 for a full day.

NOTE: Due to the spread of COVID-19, the Arizona Supreme Court Administrative Order 2020-79 requires all individuals entering a court facility to wear a mask or face covering at all times they are in the court facility. With limited exceptions, the court will not provide masks or face coverings. Therefore, any individual attempting to enter the court facility must have an appropriate mask or face covering to be allowed entry to the court facility. Any person who refuses to wear a mask or face covering as directed will be denied entrance to the court facility or asked to leave. In addition, all individuals entering a court facility will be subject to a health screening protocol. Any person who does not pass the health screening protocol will be denied entrance to the court facility.
