Dear Joseph:

As per our call this morning, Defendants have agreed to produce Scott Jarrett without the necessity of a subpoena.

The County accepted a copy of Mr. Banko's subpoena, notwithstanding your contention that the County cannot accept service because he is now not a county employee. As you know, lead counsel for the county has very recently represented to the courts that Mr. Banko is not a county employee and sought and obtained a court order that we were not to contact him on that basis. The Court agreed. This is the law of the case. This action by the county caused significant delay in our ability to locate his whereabouts and serve him with a subpoena. The county changing its position now that this delay has been incurred in placing an important witness under subpoena is not a proper litigation tactic. Please note that if the county fails to produce Mr. Banko we will expect the county will agree to entry of his declaration into the record.
