**NOTICE OF MOTION**

PLEASE TAKE NOTICE that on a date and time determined by the Court, Contestee Ilhan Omar will move the Court for entry of an order as set forth below.

**MOTION**

Pursuant to Minnesota Rule of Civil Procedure 12.02, Contestee Ilhan Omar respectfully moves the Court for an order dismissing the Notice of Contest. The Court lacks jurisdiction because Contestants failed to properly serve Contestee Omar, failed to file the contest in the proper venue, failed to demonstrate Contestants are eligible to assert this contest, and because the allegations in the Notice of Contest do not indicate that any irregularities in the election process altered the outcome of the election for Minnesota's fifth congressional district.

The motion is based upon all the files, records, and proceedings herein, and upon a memorandum of law, supporting declaration, supporting affidavits and exhibits to be filed in accordance with the Minnesota General Rules of Practice.
