ORDER GRANTING MOTION FOR EXTENSION OF BRIEFING SCHEDULE PENDING SETTLEMENT

Appellants have moved to extend the expedited briefing schedule in this case, seeking a 7-day extension of time to file the docketing statement, opening brief, and appendix. In so moving, appellants explain that they have good cause to seek an extension because they have reached a settlement agreement with respondents that would resolve this matter but still need to obtain approval and signatures from certain respondents. Appellants further state that they will either move to dismiss this appeal upon finalizing the settlement or, if settlement fails, determine how they intend to proceed by 4 p.m. on November 11, 2020.
